VIDEO RECORDING / PHOTOSHOOTING LICENSE IN THE CONTEXT OF PARTICIPATION IN THE ANTETOKOUNBROS ACADEMY

In this context of the participation of our child in the Program we acknowledge and accept also herein that according to the Terms of Participation of the Program, to which we have adhered by submitting our application:

especially regarding the filming/photographing/recording that will take place during the Program and in accordance with the Terms of Participation I/we accept also hereby and assign the right to the Company to in particular process the image, voice and participation of the minor child in the Program by recording direct or indirect, reproduction by any means or form (whole or extracts), and any kind of intangible or material vector image or sound and image during the course of the Program for the purposes set out in the Terms of Participation and in any case for non-commercial purposes, thus for the implementation and public presentation and promotion of the Program and of the Onassis Foundation Educational Programs, in electronic means, as well as in papers of all kinds both prior and during the said programs' realization, for transmittance through the Onassis Foundation website and social media and/or mass media (MM) and/or cooperating with the Onassis Foundation agencies, or in the internet or by any other means, at the Company's choice, in order to be included in the Onassis Foundation's publications, on the website of www.onassis.org and in the archive of events held in it. We hereby accept that for the above we are not entitled to any financial

consideration. In any case, such material will not be the subject to commercial exploitation without my/our written permission.

I/We also accept that the Company has the right to transmit to the co-organizers of the Academy's Programs (EUROHOOPS) the audiovisual material that will be made from such processing of data for the purposes mentioned herein.
