I declare that I have been informed about the implementation of the "Antetokounmpo Academy" Program as follows:

The American College of Greece, in collaboration with the Charles Antetokounmpo Family Foundation (CAFF), is set to undertake the execution of the "Antetokounmpo Academy" Educational Program (hereinafter referred to as "the Program") for the academic years 2023-2024 through 2027-2028.

The vision of the Antetokounmpo brothers is to provide access to sports, inspiration through education, and scholarships for young individuals from low-income families to help them shape the best version of themselves. For this purpose, the "Antetokounmpo Academy" program has been designed for boys and girls aged 10 to 17.

For this program, the American College of Greece undertakes to develop and implement, for each school year, four educational workshops for the participants, as well as to host a relevant motivational and inspirational speech on its premises. The aforementioned workshops aim to cultivate a spirit of leadership, expose fundamental concepts and methods of leadership, expand emotional intelligence, and instill necessary skills in the young participants.

I hereby affirm that I have been informed about the detailed program and fully and unreservedly accept the following conduct:

The workshops will take place on four Saturdays per school year (07/12/2024, 18/01/2025, 08/02/2025, and 22/03/2025), each lasting two hours. Participants (100-110 in number) will be divided into groups of 25-30 individuals based on their language of communication and age. At the end of the day, a lunch will be provided. On Saturday, 17/05/2025, the aforementioned motivational and inspirational speech will be delivered.

I responsibly declare that I have been informed that the CAFF, for the safe transportation of the participants, assigns an external collaborator for their transfer to and from the pick-up points and the facilities of the Agia Paraskevi Campus. The designated pick-up points are the Sepolia open basketball court and the open court in Ellinoroson, in Goudi, in Ampelokipi, on any other any location designated by the Program.

I understand and accept that Pierce- American College of Greece bears no responsibility for the transportation of participants by bus to and from the program venues. CAFF hires, from an external partner, tourist buses, which carry out the respective routes. The responsibility of choosing an external partner for the transport of the children rests with the CAFF foundation, which is committed to choosing the provider based on many years of experience and reliability in the field, to guarantee that the buses are in excellent working condition and meet the safety standards set by the applicable laws, ministerial decisions and other provisions, as well as that the drivers strictly observe the road traffic rules. The transport service provider processes only the necessary personal data for the execution of the transport service and takes the necessary protection measures, as described in the current legislation. From the moment of boarding until the moment of disembarkation, the transport service provider contracted by the CAFF foundation has full responsibility for the safety of the children.

Furthermore, with this declaration, I acknowledge that catering services are provided by a catering service contracted with the American College of Greece, which holds quality certifications from recognized authorities. I have informed the CAFF about any allergies and dietary preferences of my child.

Finally, I recognize that there is a Medical Office on the Agia Paraskevi Campus for addressing emergency situations.
